Endurance Road Racing Rules

The following rules apply **in addition** to those listed in the Roadracing section (Sec. 4) of the USCRA Rulebook:

1. No one under 18 on pit lane.
2. No smoking on pit lane.
3. Mark pit area with tape ONLY, do NOT use paint.
4. All crew members must wear long pants, shirts and sturdy shoes.
5. Each team must supply a scorer.
6. Each team will have a fire extinguisher with someone pointing it at the motorcycle during fueling.
Engines MUST be shut off during fueling.
8. Fueling towers/pressure fill systems prohibits, gravity fueling only.
9. Teams may consist of 2-4 riders. No rider may ride for a period of more than 45 consecutive minutes.
10. When entering the pit all machines must come to a complete stop. Riders must put one foot down.
Marshall will signal to continue to pit area. All riders will ONLY use 1st gear on pit lane from stop box to marked area.
11. No more than one rider on a machine at any time.
12. The winning team for each class is determined by the number of full laps completed in the 3-hour time frame. An award will be given to the top team in each class, with an additional award for overall winner (most laps completed overall).
